Salt Lake County Vital Records provides certified copies of birth certificates and death, as well as abstract of marriage and divorce records, to suitable people to receive them. Vitalis Record offices are found in public health clinics throughout Salt Lake County. You can also request an online record. The current vital records (nonhistorici) are protected, private information and are available only for the person listed on the record and the person: current parents / survivors brothers of spouses for children grandparents grandparents Other individuals are required to show the legal proof of need. The historical vital records become public at different times, depending on the type of record. Before requesting a vital record, make sure the record you are looking for is available in our offices and that is suitable for receiving it. Utah does not offer a free birth certificate for newborns. Many hospitals offer a souvenir certificate, but this copy is not legally valid and is not supplied by our office. Vitalis Record offices provide certified copies to use as a legal document throughout a person's life. The Record Department of Allen County Department of Health's Vital Records Division does not emit more certificates of birth of the portfolio size. The Vital Department of the Record Office The problems of certified offices have certified records of birth and death for events that occur at Fort Wayne and Allen County. The birth records of the County of Allen begin in 1892 for people born within the limits of the city of Fort Wayne, and in 1837 for people born outside the city's limits. Death records begin in 1871 for people who died within the city's limits and in 1907 for people who died outside the city's limits. Candidates for vital records must have a direct and tangible interest for the requested record and must be able to identify it with reasonable particularity. Identification is required for the purchase of a birth certificate or death. Options include a valid driver license, state ID or passport. A birth certificate is the first identity document of a person. Certified birth certificates are needed for employment testing, US passport applications, school registration, social security cards, other forms of identification. Certificates of birth are counterfeit-resistant documents printed on safety card with watermarks, engraving, background models in the background and sequential numbers. A birth of the hospital is transmitted electronically from the hospital to the local health department. This is usually done within five days. When a birth occurs outside a hospital, the person is required in the presence of presenting the birth with the local health department. Please contact our office for the procedure for presenting a domestic birth. Certified copies of the live birth certificate are issued only for the birth that has occurred in the County of Allen. The cost for a birth certificate is \$ 15 per copy. If you are looking for a birth certificate and are not a person named on the document, you will have to contact our office at (260) 449-7147 for instructions. Death certificates A death certificate is the legal proof of death. It is used by the government to interrupt the benefits, resolve real estate and provide rights to families. Most of the information needed to complete the death certificate is obtained from the deceased family. A doctor must complete the cause of death information and sign the death certificate. The funeral director makes the certificate completed with the local health department in the county in which death has occurred. Death death They are issued for the dead that occurred to Allen County. The cost for a certified death certificate is \$ 15 per copy, and a non-certified death certificate is \$ 2 per copy. Obtaining a birth certificate and death certificates can be obtained through our Walk-in service, mail-in service or using an online service. We accept cash, postal order, debt or credit cards (there is a minimum processing fee of \$ 1.75 for \$ 1.75 per credit / debit card transaction). We do not accept personal checks. We are not responsible for cash sent via mail as payment. Walk-in Same Service service is available by visiting the vital record office on the third floor of Building Square Citizens, 200 E. Berry St., Fort Wayne, in 46802. The office is opened by Monday to Friday , from 8.00 to 4: 30 pm except holiday observed by the government of the County of Allen. You can park in the parking lot outside the Berry road or in the nearby street parking. When you arrive, you will complete an application and pay the requested commission in cash, credit card or postal order.
